### **Refund Policy**

*PLEASE READ: When I register for this event, I understand I can cancel my order up until the event closes or sells out. Once the event is sold out or after the event close date, payroll deductions will be made. I understand no refunds for my order will be issued even if changes to Covid protocols for attending the event occur.*

*Refunds will only be issued if the event is canceled and only after the venue has reimbursed BLN. This may take 30-90 days or more, depending on the venue.*

### **PROOF OF VACCINATION & MASKING REQUIRED**

STG requires proof of vaccination for entry to all performances at the Paramount, Moore and Neptune Theatres. Only children under 12, and people with a medical condition or sincerely held religious belief that prevents vaccination, may attend without proof of vaccination. Individuals who meet those criteria must provide proof of a negative COVID-19 PCR test (date of negative PCR test result must be within 48 hours of performance time). Additionally, masking is required inside the venue. Patrons and employees will be required to wear masks, except while actively eating or drinking.
